



INVENTORY CONSIGNMENT AGREEMENT

CONSIGNOR DISCLOSURES & REPRESENTATIONS

Between: Power Packs Plus, LLC (Consignee) and _____ (Consignor)

The Consignor, by consigning aircraft parts to the Consignee for resale on a 50/50 net proceeds basis, agrees to the following terms and makes the following representations:

1. Ownership and Clear Title

The Consignor affirms and warrants that they are the legal and rightful owner of all aircraft parts consigned under this agreement. All parts are free and clear of any liens, encumbrances, or third-party claims, and the Consignor has full authority to transfer and authorize the sale of said items.

2. Traceability and Documentation

All consigned parts must be accompanied by accurate and complete traceability documentation (e.g., 8130s, teardown reports, historical usage, or other applicable certifications) as required by industry standards. The Consignor certifies that all provided documentation is accurate and reflects the true origin, condition, and compliance status of the part(s).

3. Authorization to Sell

The Consignor grants the Consignee the right to market, advertise, and sell the consigned aircraft parts at a mutually agreed price, or at the Consignee's discretion if no pricing is pre-established. Consignee may offer discounts or negotiate pricing in good faith to facilitate sale.

4. Revenue Share and Proceeds

Sales proceeds will be split 50/50 between the Consignor and Consignee, based on **net proceeds**, defined as the gross sale price **minus** any directly incurred transaction fees (e.g., marketplace fees, payment processing, shipping, packaging, or certification costs, if applicable).

5. Indemnification

The Consignor agrees to indemnify, defend, and hold harmless the Consignee against any liability, loss, claim, or expense (including legal fees) arising from misrepresentation of ownership, improper documentation, noncompliance with FAA/EASA regulations, or any claim of defect, unairworthiness, or mislabeling.

6. Condition of Parts

The Consignor affirms that all consigned parts are accurately described, with disclosed condition status (e.g., AR, OH, SV, NS, As Removed), and free from hidden damage, corrosion, or tampering. Any known defects or limitations must be disclosed at the time of consignment.

7. Return of Unsold Inventory

Consigned parts that remain unsold may be returned at any time upon reasonable written request by either party. Return shipping shall be at the Consignor's expense, unless otherwise agreed.

8. Termination

This agreement may be terminated by either party with written notice. Unsold items will be returned promptly. Any active sale negotiations underway at the time of termination shall be completed and proceeds distributed as agreed.
